To our actual knowledge, based on review of the court records in Ouray County and Montrose County, Colorado and the Public Access to Court Electronic Records (PACER), there is no litigation involving the Districts' public improvements as of December 31, 2023.

The Districts had no Public Improvement construction activity in 2023.

District 2 had sufficient funds to cover the June 1, 2023 interest payment, but had a shortfall of \$164,712 in available funds to make the December 1, 2023 interest payment and \$0 funds available to pay current and prior years principal for the Series 2010A Bonds. Additionally, the District was not able to make any payments on the Series 2010B Bonds. Debt service shortfalls are anticipated to continue into future years, however because the District continues to levy the required mill levy this shortfall is not an event of default.

The Districts had no Public Improvement construction activity in 2023.

The list of facilities and improvements constructed by the Districts and accepted by Montrose and Ouray Counties did not change in 2023.

11. Any inability of the Districts to pay their obligations as they come due, in accordance with the terms of such obligations, which continue beyond a thirty (30) day period.

District 2 had sufficient funds to cover the June 1, 2023 interest payment, but had a shortfall of \$164,712 in available funds to make the December 1, 2023 interest payment and \$0 funds available to pay current and prior years principal for the Series 2010A Bonds. Additionally, the District was not able to make any payments on the Series 2010B Bonds. Debt service shortfalls are anticipated to continue into future years, however because the District continues to levy the required mill levy this shortfall is not an event of default.

12. Any other defaults of any kind of the Districts' obligations, agreements, contracts, intergovernmental agreements, or duties.

To our knowledge, there are no other defaults of the Districts' obligations, agreements, contracts, intergovernmental agreements, or duties.
